**RECITALS**

- 1) WHEREAS, Chapter 9 of Part 5 of Division 26 of the Health and Safety Code establishes the Carl Moyer Memorial Air Quality Standards Attainment Program (“Carl Moyer Program”) which is administered by the Air Resources Board and which provides incentives for cleaner heavy-duty engines throughout the State of California; and
- 2) WHEREAS, the Santa Barbara County Air Pollution Control District, with authorization from its Board of Directors, has participated in the first six funding years of the Carl Moyer Program, and has received Air Resources Board grants totaling \$1,623,987 as a means to reduce near-term oxides of nitrogen (NOx) and particulate matter (PM) emissions from heavy-duty engines in Santa Barbara County; and
- 3) WHEREAS, the California Legislature has authorized \$30.5 million in smog check fees for project funding for fiscal year 2004/2005 (Year 7) of the Carl Moyer Program; and
- 4) WHEREAS, the Air Resources Board has tentatively allocated \$332,629 in funding to the District for fiscal year 2004/2005 (Year 7) Carl Moyer Program, and must encumber the Year 7 funds to the District by June 30, 2005; and
- 5) WHEREAS, the Air Resources Board requested that air districts submit their placeholder applications by December 1, 2004 to reserve their allocation of funds from the Year 7 Carl Moyer Program, and also suggested that participating air districts apply for more than their tentative allocation in case more state funds become available for distribution; and
- 6) WHEREAS, to meet this deadline and request additional funds, the District submitted a placeholder application to the Air Resources Board by December 1, 2004, to participate in the Year 7 Carl Moyer Program, and requested a grant amount of up to \$400,000 in program funds, which, if approved, will be used with the required District matching funds (not to exceed \$200,000) to fund cleaner heavy-duty engine projects in Santa Barbara County over the next two years.

**NOW, THEREFORE, IT IS HEREBY RESOLVED THAT:**

- 1) The Board hereby approves the District's participation in the fiscal year 2004/2005 (Year 7) Carl Moyer Program administered by the Air Resources Board, and approves the submission of the Grant Award and Authorization Form; and
- 2) The Board hereby certifies that it will provide the required matching funds (not to exceed \$200,000), over the period from July 1, 2005 through June 30, 2006, necessary to qualify for up to a \$400,000 grant in Carl Moyer Program funds from the Air Resources Board; and
- 3) The Air Pollution Control Officer is hereby authorized and empowered to execute in the name of the Santa Barbara County Air Pollution Control District the attached Fiscal Year 2004/2005 Program Application and Grant Award and Authorization Form with the Air Resources Board and all other incidental documents to participate in the fiscal year 2004/2005 (Year 7) Carl Moyer Program.
